### Welcome and Opening of Meeting

The meeting was called to order at 12:10 p.m. by Mr. Craig Jacobs, Chair.

### **Financials**

Mr. Brent Bishop, Chief Financial Officer of Upstate Workforce Board, reviewed the SC Works Operating and Rapid Response financials from July 1, 2015 through January 31, 2016. Mr. Bishop noted that the most recent modification (newly obligated funds and the transfer of Dislocated Worker to Adult funds) were included and therefore more accurately reflected in the financial report. The SC Works budget is on track. Mr. Bishop also noted that two Rapid Response IWT grants had ended on January 31, 2016 and two more were ending in March 2016; however, Ms. Johnny-Lynn Crosby was attempting to obtain an extension for one of the grants. There were no additional questions or concerns.

### SC Works Update

Mr. Douglas Stephenson, Project Director of Rescare, provided several updates for SC Works:

- Mr. Henry Giles offered to allow SC Works staff utilize space at SCC Cherokee Center for Advanced Manufacturing and Industrial Technologies (CAMIT), at least through June 2016. This will give staff a full time presence in the county until SCDEW and the area finalize/approve the RSAs for PY14 and PY15
- SC Works is in partnership with UWB, Vocational Rehab and Sgt. Neil Urch of the Spartanburg
  Detention Center in applying for a Department of Labor grant to establish an actual job center-type
  service within the detention center.
- The Annual Job Fair will be May 5, 2016. Sponsors have already committed; in past years it has been
  difficult to obtain them. However, employers have worked with Ms. Crosby and her Business Services
  team, confident in SC Works- Upstate delivering quality services in a timely, professional manner.
- % of Training Distribution-- number of participants based as of January 31, 2016:
  - 69% -- Manufacturing
  - 14% -- Trades
  - 17% -- Other
- Approximately 70% of training/support services funds has been obligated.
- Rescare-Career Pathways Explorer, effective March 1<sup>st</sup>, will be utilizing a new personality assessment
  called Woofound, which provides a better understanding of one's personality and allows better
  decisions about career direction.
- Able SC held an informative and well-attended Disability Benefits & Employment seminar in the SC Works-Upstate location. Approximately thirty participants from Able SC, Commission for the Blind and Vocational Rehab were in attendance.

 MOU/RSA – A few signed agreements are still needed. Vocational Rehab and Department of Social Services are currently pending at the state level, while SC DEW has not returned their signed agreement. All signatures are required before it can go before the Upstate Workforce Board.

### **DOL/FOIA Update**

Ms. Ann Angermeier, Mr. Curtis Anderson and Ms. Dana Wood met with Attorney Lewis Cromer in Columbia on Wednesday, January 27, 2016. Mr. Cromer agreed to send a letter containing backup documents to the Department of Labor, responding to the SCDEW monitoring response from Ms. Cheryl Stanton, Executive Director.

## Highlighted Happenings:

On January 8<sup>th</sup>, Lajuana conducted two training sessions for Vocational Rehabilitation staff from Spartanburg, Cherokee, and Union. The training was on how to better utilize SC Works Online System (SCWOS) and some networking tools to better serve their clients.

Lajuana and Meika conducted a rapid response session on the 12<sup>th</sup> with HR Manager, Ava Cooley of ADS in Cherokee County. The closure effects 105 employees. On the 14<sup>th</sup> Meika conducted two orientation sessions with 65 employees to discuss WIOA and workshops offered through SC Works.

On the 13th Lajuana participated in the Quarterly Family Self-Sufficiency/Homeownership/Connections Program Coordinating Committee meeting at the CC Woodson Community Center.

Maria and Meika attended the Hispanic Alliance meeting on the 15th hosted by Arcadia Elementary. Arcadia Elementary offers a variety of services to students and their parents. One program offers students breakfast, lunch and dinner. Another offers an adult education program and parenting classes that include free child care. Nancie Strover from DHEC spoke about their new Diabetes Prevention Program in Spartanburg. Wofford College, USC Upstate, Vocational Rehabilitation, Mary Black Foundation, Upstate Family Resource Center, and PASO's were among the organizations present.

Nancy, Kenneth, and Meika assisted the BST in supporting a Cooper Standard Automotive recruitment event. They provided screening assistance and event management at events in Duncan and Gaffney. 257 candidates attended the recruitment event on January 19<sup>th</sup> in Duncan and 47 attended the event in Gaffney on the 20<sup>th</sup>. Overall, Cooper Standard was very pleased with the candidates and was very appreciative of the support provided by SC Works. Upstate.

On January 21st Kenneth went to the Goodwill Job Connection on Asheville Highway to conduct an on-site Resume Pro workshop. There were five people in attendance.

On January 14th, three members of the Upstate BST attended a very informative Business Intelligence Training Seminar, hosted by Spartanburg Community College and facilitated by the Center for Regional Economic Competiveness. The training has better equipped our team to provide local, current labor market data to industry, upon request.

South Carolina Vocational Rehabilitation (SCVR) was the guest speaker for the community/business partner meeting held on January 22<sup>nd</sup> at SC Works Spartanburg. Thank you to SCVR for a fantastic partnership!

On the 29th, Johnnie-Lynn and Dwayne Hatchett, Workforce Solutions Manager with the Upstate Workforce Board, facilitated a series of workshops for local K-12 Career Counselors/Teachers at the Education and Economic Development Act/ Career and technology education (EEDA/CATE) Winter Conference.
